

# ONLINE PRIVACY POLICY AGREEMENT

Purpose LLC ( Purpose) values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with Purpose LLC of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

### **Use of Information Collected**

Purpose LLC does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

Purpose LLC may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. - as necessary to maintain, safeguard and preserve all the rights and property of Purpose LLC.

### **Notice to European Union Users**
